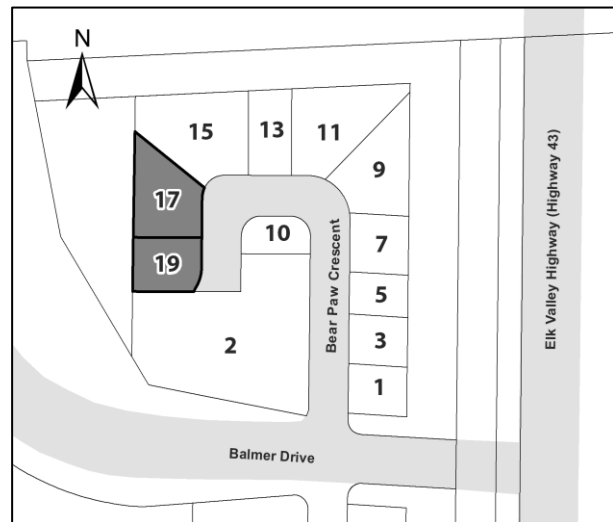

**Location:** 17 & 19 Bear Paw Crescent

**Legal Description:** Lot E, Plan NEP91179 and Lot 2 Plan EEP61998, District Lot 8965

**Purpose:** One Principle Building and One Dwelling Unit per Parcel is permitted in the C-2 Service Commercial Zone of the District of Elkford Zoning Bylaw No. 737, 2013, as amended. The property owner has applied for a Temporary Use Permit to allow for four Principle Buildings and six Dwelling Units on the subject properties for 9 months between October 2018 and July 2019.

- 3. The Permittee, as a condition of the issuance of the Permit, agrees:
  - a) The placement of a four (4) temporary Principle Buildings will be as shown on "Schedule B".
  - b) The temporary Principle Use of three (3) buildings will be six (6) dwelling units as shown on "Schedule C".
  - a) The buildings meet all the requirements of the BC Building Code.
  - b) The development meets all the requirements of Development Permit No. 18-02.
- 4. This Temporary Use Permit will expire on July 11, 2019. All temporary buildings must be removed on or before that date.
- 5. This Permit shall not have the effect of varying any floodplain specifications under Section 524 of the Municipal Act.
- 7. Notice of this Permit shall be filed in the Land Title Office at Kamloops, British Columbia under Section 503(1) of the Local Government Act, and upon such filing, the terms of this Permit or any amendment hereto shall be binding upon all persons who acquire an interest in the Land affected by this Permit.
- 8. The Land shall be developed strictly in accordance with the terms and conditions and provisions of this Permit and any plans and specifications attached hereto which shall form a part thereof.
- 9. This permit is not a Building Permit.
